BOARD MEMBER UPDATES

Bob Roth: Cowlitz County NWCB coordinator Angelica Velazquez produced their annual report and presented it to their commissioners, where it was well received. The report was built around their goals and objectives and was available to anybody interested in a copy.

Jerry Hendrickson: In Asotin County they were already fighting yellow starthistle this year and were working with landowners to curtail it in their area.

Commissioner DeTro: Currently had 3" of snow in Okanogan.

Butch Klaveano: Yellow starthistle exploded in Garfield County last year, and the weed board was working out cost share program.

OFFICE REPORT

The Board reviewed office reports for January and February Alison:

January and February were full of travel and bad weather. The biennial report had been
mailed out to all county weed board members, coordinators, and all county boards of
commissioners or councilpersons.

Wendy:

• Weather was also a factor when she traveled to give presentations. The Flower and Garden Show at the Washington Convention Center in Seattle was a success, and Wendy thanked the surrounding county weed board staff who helped staff the booth.

The Board discussed:

• Updating county funding levels. Wendy had recently requested updated information from all the counties.

• Skamania County NWCB's budget was substantially reduced, due to county budgetary shortfall. Justin Bush mentioned that it would impact staffing, but that the program was largely grant-funded, which keeps them afloat in the short-term.

WSDA UPDATE

Mary Toohey & Greg Haubrich:

- Legislature still working on budgets. At the time, there were no anticipated reductions for the WSNWCB budget. They were deliberating appropriation source for WSNWCB and some or all of Plant Protection program if it was not going to come out of general fund in the short-term.
- Annual Spartina report undergoing final review and would be available soon.
- Bridget Simon was back in Washington and would be working part-time for WSDA.

The Board discussed:

• The importance of board members talking to their legislators about the importance of continued funding of the WSNWCB.

LEGISLATIVE UPDATE

Alison: HB2413 (regarding pesticide drift on workers and community members) and its substitute versions never made it to either house or senate floor for a full vote this session. The WSNWCB provided testimony at all three hearings, and there were many in the agricultural and natural resource sectors who testified in opposition to the bill. Many legislators appeared very educated about pesticide safety and regulation and understood the negative impacts of the bill as originally written.

The Board discussed:

- The importance of continued discussions with legislators about existing safeguards with pesticides.
- Commissioner DeTro stressed the need to be vigilant about future versions of this bill. Okanogan County has the largest single proprietor of orchard fruit? in the world, and he was concerned that the bill would have significantly harmed the orchard industry in Washington.

FINANCIAL REPORT

Alison: Not much to report. The online meetings are being paid out of the education fund but were allocated in the state weed board fund, so both accounts are slightly off, but they balance out. GoToMeeting costs are being reduced by cancelling the toll-free number service during months when the Board is not holding meetings.

REVIEW OF CLASS A ERADICATION PROPOSALS

The Board reviewed the Class A eradication proposals.

The Board discussed:

- There was a total of \$18K allocated for Class A projects.
- The benefit of having licensed county NWCB staff or contracted applicators apply restricted-use herbicides on noxious weed infestations.
- RFPs should be improved to provide better information (landowner, cost-share, infested acres, etc.)
- WSDA already had a USFS FHP intercounty agreement with Skamania County and could fund the \$3,000 garlic mustard project.
- The Board could reallocate \$994 from its budget so that all remaining projects could be funded.

REVIEW AND DISCUSS CODE OF ETHICS (COE)

The Board reviewed its adopted COE and the suggested language submitted by Tony. The Board discussed:

- Sarah read through Tony's suggested text and was concerned that it only addressed fiscal conflicts of interest (COI) and would have an attorney determine what constituted a COI. That would take the power away from the Board and could also be extensive.
- Tony had taken the Board's COE and simplified the language to make it more concise.
 He expressed concern that there was no specific basis on what could remove a person
 from the Board. He did not mind continuing with the current COE while the Board
 continued to revise it.
- Butch created a temporary sub-committee of Tony, Sarah, and Alison to work on the COE before the next meeting.
